Founded in 2007, Serious JuJu Skateworks, Inc. is a nonprofit organization. We provide Montana's only free indoor skateboard park where children are nourished and supported. We aim to See, Feed, and Strengthen Youth and Families through the actions of God's Love. Over the past 15 years we have served our community, having a positive impact on thousands of at-risk youths and their families. Many of the children that walk through our doors are seeking shelter; shelter from their home lives, shelter from their troubles, shelter from all of the confusion and instability around them. With the support of our volunteers, meal donors, and our financial donors we provide a safe space where individuals can be celebrated and strengthened through skateboarding.

Currently we host (6) six skateboarding sessions a week, offer private skatepark rental opportunities, and looking forward to providing an extensive afterschool program in the fall of 2023.

## BOARD ROLES AND RESPONSIBILITIES

- ◆ **Terms of Office:** The members of the Board of Directors are elected for three-year terms.
- ◆ **Meetings:** Board members are expected to participate in monthly meetings.
- ◆ **Committee Requirements:** Board members are expected to be an active participant in Board correspondence, voting, special events, and organizational/program promotion. Board members may be responsible for outside project work in support of the donor acquisition and engagement. Board members are required to attend a minimum of 10 skate sessions per year and are encouraged to make an annual/monthly financial contribution at a level that is personally significant.
